Your donations may also be eligible for a matching grant from your employer. To find out if your employer will match your donation to a non-profit organization, inquire of your human resources department about a matching donation program.

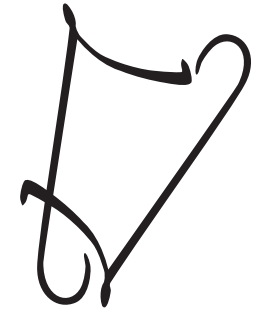

What is the Foundation?

Founded in 1993 as a separate support organization of the American Harp Society, the AHS Foundation is a nonprofit [509(a)(3)] organization in which donations are held for specific educational projects such as scholarships, awards and prizes, each in accordance with the intent of the original donor.

The Foundation was created to establish an endowment to ensure the funds and their growth in perpetuity.
